ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of amending and restating the Articles of Organization of a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Amended and Restated Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be **ZPH INTERNATIONAL, LLC** ("Company").

ARTICLE II

Address. The street address of the principal office is 929 Rolling Acres Road, Unit 102, Lady Lake, FL 32159 and the mailing address is P.O. Box 1867, Ocala, FL 34478.

ARTICLE III

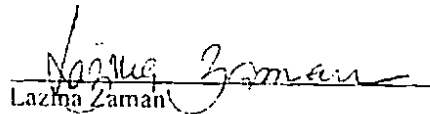
