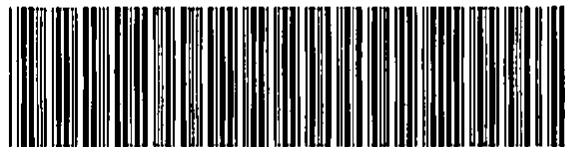

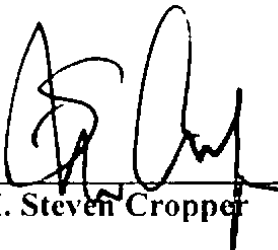
## **ARTICLE V – Admission of Additional Members**
