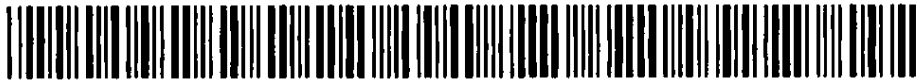

The undersigned, Thomas T. Gallion IV, a natural person competent to contract and an authorized representative of KISS BAR 2, LLC, hereby presents these Articles of Organization as the Articles of Organization of KISS BAR 2, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is KISS BAR 2, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

ARTICLE II – PRINCIPAL OFFICE ADDRESS

ARTICLE III – PURPOSE AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

ARTICLE V – REGISTERED OFFICE AND AGENT

The initial registered office of the Company is 1875 South County Hwy 393, Santa Rosa Beach, Florida 32459 and the name of the initial registered agent at that address is Thomas T. Gallion IV.

ARTICLE VI – MANAGEMENT

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement for the Company. The names and addresses of the initial managers of the Company are as follows:




