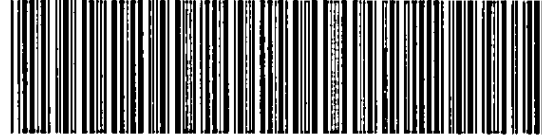



A. ENTITY NAME. The name of the Company shall be as follows:


