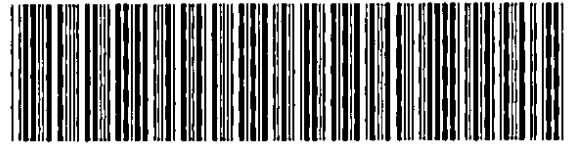

The undersigned authorized representative to form a limited liability company pursuant to these articles of incorporation, being duly licensed to practice law under the laws of the state of Florida, adopt(s) these articles to form a limited liability company under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapters 605 and 621, and other laws of the state of Florida.

ARTICLE I. NAME

The name of the professional limited liability company is WEINBERG LAW, PLLC.

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. PURPOSE




