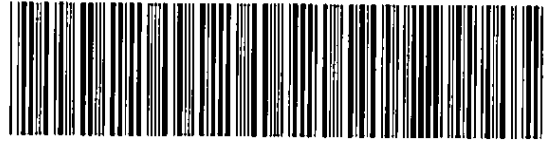

The Articles are hereby amended as follows:

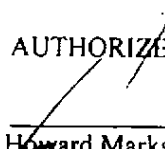
- I. Article IV of the Articles is deleted in its entirety and replaced with the following:
