**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION OF
MOORHEAD EAT, LLC**

THESE ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF MOORHEAD EAT, LLC, a Florida limited liability company (the "Company"), are executed by the undersigned Authorized Representative of the Company for the purposes set forth herein:

1. The name of the limited liability company is Moorhead EAT, LLC.
2. The Articles of Organization were filed on November 24, 2020, effective November 23, 2020, and assigned document number L20000360932.
3. On July 8, 2021, Stephen R. Moorhead, sole member of the Company, (i) assigned all of the membership interests in the Company to ROBERT C. SANSING; and (ii) resigned as Manager of the Company.
4. The Company has approved to make the following changes to the Articles of Organization: (i) changing the name of the Company from Moorhead EAT, LLC to SM Connector, LLC; (ii) amending the principal office address of the Company; (iii) amending the registered agent and office of the Company; and (iv) changing the current manager of the Company.
5. The Company has adopted the following amendments to the Articles of Organization:

- I. Article I is hereby amended and restated in its entirety to read as follows:

ARTICLE I - NAME

The name of the limited liability company is SM Connector, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

- II. Article II is hereby amended and restated in its entirety to read as follows:

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE V – REGISTERED OFFICE AND AGENT

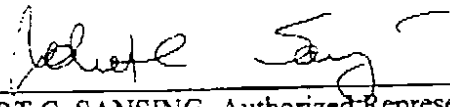
