**ARTICLES OF ORGANIZATION
OF

The undersigned, DALE C. MOORE and SHEILA A. MOORE, husband and wife, both natural persons competent to contract and together, as tenants by the entireties, the sole member of I-110 EAST, LLC, hereby present these Articles of Organization as the Articles of Organization of I-110 EAST, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is I-110 EAST, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 850 North Tenth Avenue, Pensacola, Florida 32501. The Company's principal office may hereafter be at such other place or places as the member from time to time may determine.

ARTICLE III - PURPOSES AND POWERS

ARTICLE VI - MANAGEMENT




