ARTICLE IV – Management:

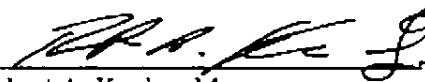

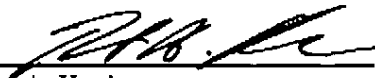
**CERTIFICATE OF DESIGNATION OF
