**ARTICLES OF ORGANIZATION  
of  
ADVANTAGE AUTO TRANSPORT, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be Advantage Auto Transport, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 6 Prince Patrick Lane, Palm Coast, Florida 32164.

**ARTICLE II**

**PURPOSES AND POWERS**

**DURATION AND COMMENCEMENT**




