**ARTICLES OF ORGANIZATION

**ARTICLE I - NAME**

In accordance with Section 605.0201(2)(a) of the Revised Act, the name of the limited liability company is **THE FRENCH KNOT, LLC**.

**ARTICLE II - ADDRESS**

**ARTICLE IV – MANAGEMENT OF THE COMPANY**




**ARTICLE VII – LIMITED LIABILITY**
