PLAN OF CONVERSION

This Plan of Conversion (the "Plan), dated as of November 17, 2020, is hereby authorized, adopted and approved for purposes of converting its existence from a California Limited Liability Company (the "Converting Entity") to a Florida limited liability company (the "Converted Entity") pursuant to Chapter 607, F.S.

- 2. <u>Tax Consequences.</u> This conversion is intended to qualify as a reorganization under 26 U.S.C. 368(a)(1)(F) of the Internal Revenue Code.
- 3. <u>Certificate of Conversion by Converting Entity.</u> The Company shall prepare and file a Certificate of Conversion with the appropriate filing office of its state of formation.
- 4. <u>Certificate of Conversion by Converted Entity; Formation Documents.</u> The Company shall prepare and shall file with the Florida Department of State. (a) a Certificate of Conversion and (b) an Articles of Organization for the Converted Entity, along with payment of the appropriate filing fees.
- 5. <u>Conversion of Interest.</u> Each unit of the Company's limited liability interest shall convert to equal percentages of limited liability interest in the Converted Entity.
- 6. Effective Date. The conversion will become effective on November 17... 2020.
- 7. Governing Law. This Plan shall be governed by the laws of the State of Florida.
