ARTICLE I. NAME

The name of the limited liability company is FlyteOne Aviation Services LLC.


ARTICLE II. ADDRESS

The limited liability company shall, to the full extent permitted by Section 605.0408, of the Florida Statutes, as amended from time to time, indemnify all persons whom it may


