The name of the limited liability company is FlyteOne Leisure Services LLC.


ARTICLE II. ADDRESS

ARTICLE V - INDEMNIFICATION


The limited liability company shall, to the full extent permitted by Section 605.0408, of the Florida Statutes, as amended from time to time, indemnify all persons whom it may
