ARTICLES OF DISSOLUTION OF HORIZON HOLDINGCO, LLC, A FLORIDA LIMITED LIABILITY COMPANY

The occurrences that resulted in the dissolution of the Company are as follows: (i) the sole member of the Company has determined to dissolve the Company, distribute its assets and wind up its affairs; and (ii) all members of the Company have dissociated from the Company and withdrawn therefrom, resulting in the Company having no members.
