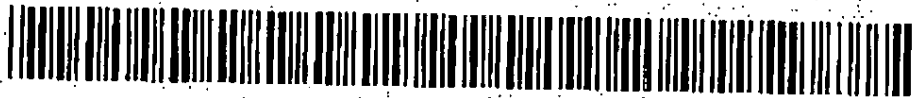


**ARTICLE III
