**ARTICLES OF ORGANIZATION  
FOR

**A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, acting as the organizer of ENNS LLC, under the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the limited liability company is ENNS LLC.

**ARTICLE II  
INITIAL PRINCIPAL OFFICE**


