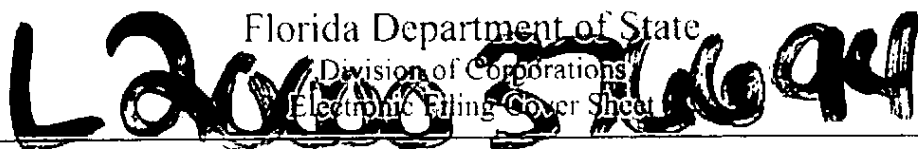

Managers may be appointed or removed in the manner provided in the Operating Agreement of the Company.


5. **Amendment.** These Amended and Restated Articles of Organization may be amended in the manner provided in the Operating Agreement of the Company.


