# ARTICLES OF ORGANIZATION OF LCF WESTON CAPITAL, LLC

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Organization for the purpose of creating a limited liability company under the laws of the State of Florida.

#### **ARTICLE I**

The name of this limited liability company shall be: LCF Weston Capital, LLC

#### ARTICLE II

#### **ARTICLE III**

The limited liability company will commence effective as of December 10, 2020, and shall exist perpetually thereafter unless sooner dissolved.


