ARTICLES OF ORGANIZATION
of
RMR ADVISORS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be RMR Advisors, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 2654 Long Boat Court South, Ponte Vedra Beach, Florida 32082.

ARTICLE II

PURPOSES AND POWERS

ARTICLE VII**DURATION AND COMMENCEMENT**


