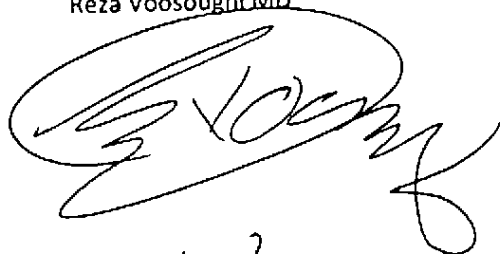
Re: Dissolution of Voosoughi Anesthesia Inc
