



Article VIII

In the event of withdrawal, death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in this company, this Limited Liability Company shall remain in existence and the remaining members have the right to continue in business pursuant to the applicable provisions of the regulations.

Article IX

The members of the Limited Liability Company shall adopt, after, amend or repeal regulations containing all provisions for the regulation and management of this company, which shall be consistent with the laws of the United States of America, the laws of the State of Florida, the Operating Agreement or the Articles of Organization.

Article X

Members of the Limited Liability Company have the right to admit new members. Acticle XI

The assignee shall merely be entitled to receive the share of profits, distributions, allocation of income, gain, loss deduction, credit or similar item to which the assignor was entitled, to the extent assigned.

Article XII

Unless otherwise provided in the Limited Liability Company Operating Agreement, there shall not be any distribution of profits unless each separate distribution is approved by the affirmative vote of member(s) who own more than fifty percent (50%) of the voting interest in the Limited Liability Company. The voting member(s) shall have complete discretion on when and if to approve any distribution of profits.

Article XIII

These Articles of Organization may be amended at any time by the unanimous consent of the members as deemed appropriate to facilitate the accomplishment of the purpose of the Limited Liability Copipany. The amendment shall be executed and duly file with the Florida Department of State.
