ARTICLES OF ORGANIZATION OF R KLEMENT HOLDINGS, LLC

The undersigned authorized representative hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company (the "Limited Liability Company") in accordance with the laws of the State of Florida.

ARTICLE I. NAME

The name of the Limited Liability Company shall be R Klement Holdings, LLC.

ARTICLE II. DURATION; EFFECTIVE DATE
