**ARTICLES OF ORGANIZATION
FOR

**ARTICLE I
NAME**

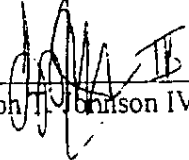
**ARTICLE IV

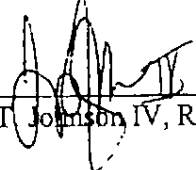
