#### ARTICLES OF ORGANIZATION FOR JCJ SPRINGTIME, LLC

#### A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of JCJ SPRINGTIME, LLC, under the Florida Revised Limited Liability Company Act, Chapter 605, <u>Fla. Stat.</u>, adopts the following Articles of Organization:

#### ARTICLE I NAME

The name of the limited liability company is JCJ SPRINGTIME, LLC.

#### ARTICLE II <u>INITIAL PRINCIPAL OFFICE</u>
