

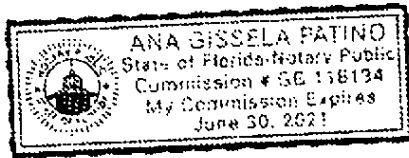


ARTICLE VII
