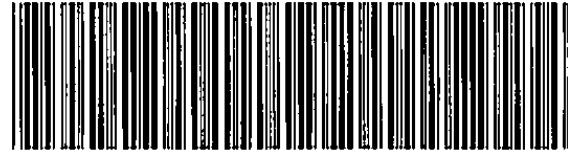

ARTICLE VIII - REGISTERED OFFICE AND REGISTERED AGENT

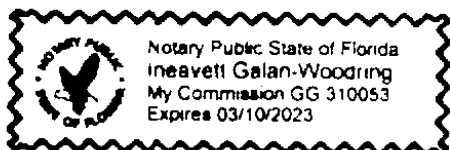
