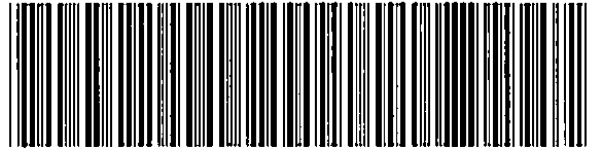

The name of the Limited Liability Company is "**T&L Lee Family Holdings, LLC**" (the "**Company**").


