Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, ALTAMONTE SS LLC adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the limited liability company is ALTAMONTE SS LLC (the "Company").

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on December 18, 2020, under Document Number L20000395711.
