OF






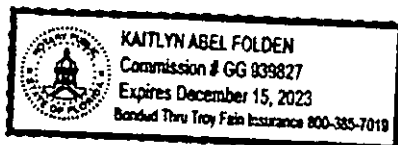
