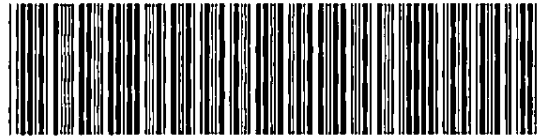


1. That Article I of the Articles of Organization be amended to read as follows:
