ARTICLE I – Name:

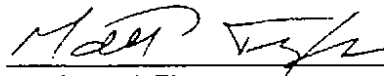
ARTICLE VIII – Continuation of Business:

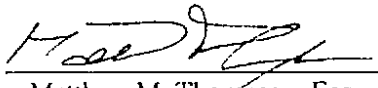
