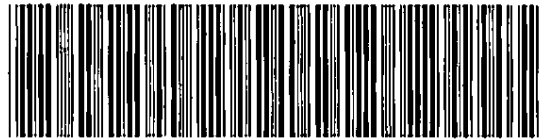

ARTICLES OF CONVERSION

Pursuant to the provisions of Section 607.11933 of the Florida Business Corporation Act and Section 605.1045 of the Florida Revised Limited Liability Company Act, DIRECT AUTOMOTIVE MANAGEMENT, INC., a Florida corporation (the "Converting Entity"), hereby delivers these ARTICLES OF CONVERSION and attached ARTICLES OF ORGANIZATION for the purpose of converting the Converting Entity from a Florida corporation to a Florida limited liability company pursuant to the provisions of Section 607.11930 et seq. of the Florida Business Corporation Act, and Section 605.1041 et seq. of the Florida Revised Limited Liability Company Act.

1. The name of the Converting Entity immediately prior to the filing of the Articles of Conversion is DIRECT AUTOMOTIVE MANAGEMENT, INC. P03000114448
2. The Converting Entity is a Florida corporation first formed under the laws of the State of Florida on October 15, 2003.

The undersigned hereby organizes a limited liability company under the provisions of the Florida Revised Limited Liability Company Act, and pursuant to the following Articles of Organization:

ARTICLE 1

Name

The name of this limited liability company (hereafter, the "Company") is:

The Company is to be managed by one or more managers and is, therefore, a manager-managed company. The name and address of the current manager of the Company are:

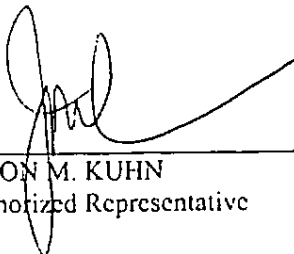
