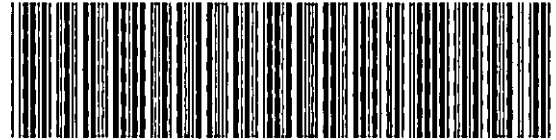

This Limited Liability Company shall commence January 1, 2021, and shall have perpetual existence.

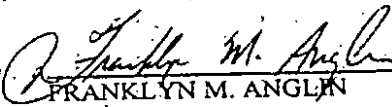

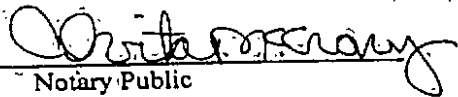
