**ARTICLES OF ORGANIZATION

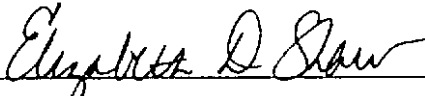

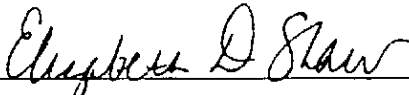

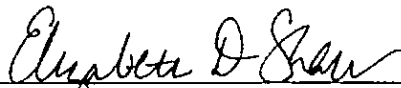
