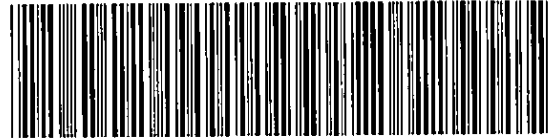


**ARTICLES OF CONVERSION
