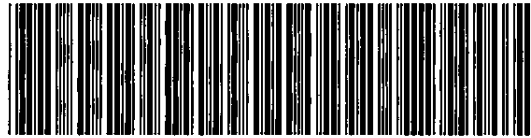

ARTICLE IV - APPROVAL OF DISSOLUTION

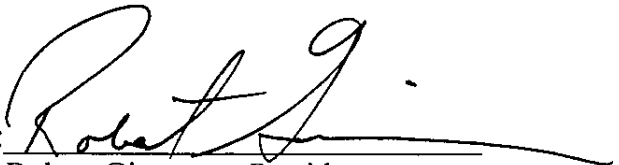
