
- a. As of January 1, 2002, my company was changed from a "C" Corporation to an "S" Corporation: I didn't learn until just last week at a meeting with my Accountant that it was necessary for me to file the 2002 URB report even though my business is now an "S" Corporation;
- b. Since the time of incorporation of my business in 1989, I believe that the reports to the Division of Corporation have been submitted in a timely manner; and,
- c. My business is a one-man operation: I have suffered through a period of severe financial difficulties associated with a divorce over the period of 1999/2000, and am still attempting to recover from those problems.

I apologize for the delay in submitting this report: had I known that I was required to submit this report given the new corporate status as an "S" Corporation I can assure you that I would have submitted in a timely manner. I also intend to submit all future URB reports and payments in a timely manner.
