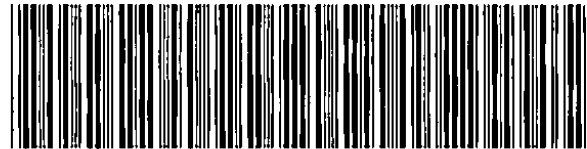

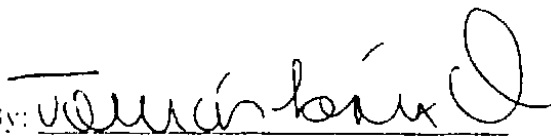

**ARTICLES OF ORGANIZATION  
OF  
BOLUCY INTERNATIONAL LLC**

The undersigned, being the Manager, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the limited liability company is Bolucy International LLC (the "Company").

**ARTICLE II  
ADDRESS**

The principal office and mailing address of the Company is as follows: 1010 Brickell Avenue, Apt. #1607, Miami, Florida 33131.

**ARTICLE III  
REGISTERED AGENT AND OFFICE**

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

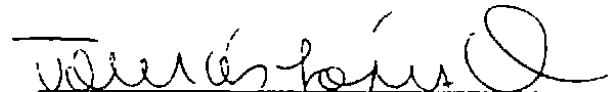
**ARTICLE VII**
