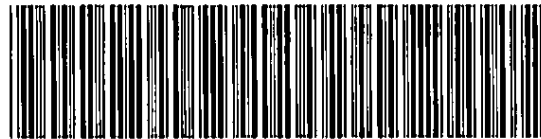

Management of Business**




