**ARTICLES OF ORGANIZATION**  
*of*

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be Emily Witte Voice Studio, LLC (the "**Company**"). The mailing and street address of the principal office of the Company shall be 2438 Brelade Place, Charlotte, North Carolina 28203.

**ARTICLE II**

**PURPOSES AND POWERS**

The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The managers shall hold the offices and have the responsibilities accorded to them by the members as set forth in the Operating Agreement. ## **ARTICLE VII**


### **DURATION AND COMMENCEMENT**
