The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapters 605 and 621, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

ARTICLE V - PURPOSE


