**ARTICLES OF ORGANIZATION
OF
KATHERINE T. GERMAN EMERGENCY MEDICINE, PLLC**

1. Name. The name of this limited liability company is Katherine T. German Emergency Medicine, PLLC (the "Company"), and it shall be formed as a professional limited liability company under Chapter 621 of the laws of the State of Florida.

2. Duration. The period of duration for the Company shall be perpetual, unless terminated in accordance with the Company's Operating Agreement.

3. Purpose. The general nature of the business to be transacted by the Company is to engage in every phase and aspect of the business of rendering the same professional services to the public that a medical doctor, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through members, officers, employees, and agents of the Company who are duly licensed under the laws of the State of Florida to perform said services.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 913 Saratoga Dr., Jacksonville, FL 32207.

5. Registered Agent and Office. The name and street address of the initial registered agent of the Company is Katherine T. German, 913 Saratoga Dr., Jacksonville, FL 32207.

6. Management of the Company. The management of the Company shall be vested in the managers of the Company. The initial manager of the Company is Katherine T. German, MD, 913 Saratoga Dr., Jacksonville, FL 32207.

7. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
