The name of the Limited Liability Company shall be **BE MADE LLC** (the "Company").

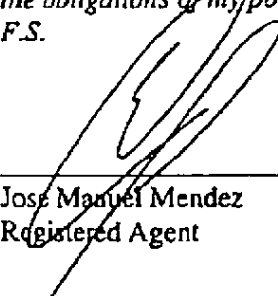
ARTICLE II - Nature of Business and Mailing Address:
