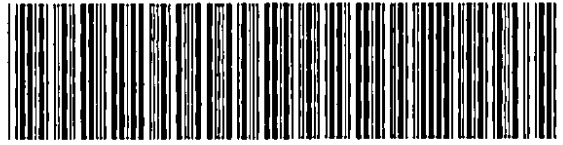

The name of the Florida Limited Liability Company is **Mister Beau 19, LLC**.




