ARTICLES OF ORGANIZATION**

OF

1. The name of the limited liability company is Mercado Pago International LLC (the "Company").
2. The Articles of Organization for the Company were filed on January 11, 2021, and assigned Florida Document Number L21000008503.
3. The Company hereby adopts the following Amended and Restated Articles of Organization which were duly executed and are being filed in accordance with Section 605.0202 of the Florida Revised Limited Liability Company Act (Florida Statutes Chapter 605).

ARTICLE I - NAME
