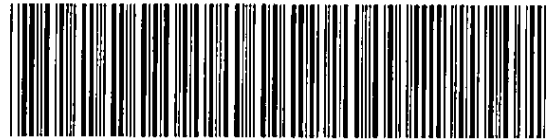

MANAGEMENT


