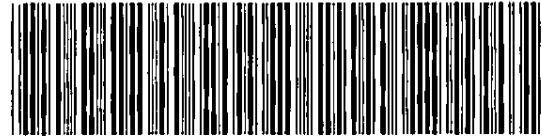



ARTICLE VI – INITIAL MANAGER AND OFFICER


