#### PLAN OF CONVERSION

This Plan of Conversion ("Plan") is entered into this 28th day of December, 2020, by Mihail Stoyanov ("Stoyanov"), the sole member and manager of Laketown Wharf 1530 LLC, a Colorado limited liability company ("Laketown").

- 1. <u>Conversion</u>. Pursuant to the terms and subject to the conditions stated herein, Laketown will be converted from a Colorado limited liability company to a Florida limited liability company with the name "Laketown Wharf 1530 LLC", which limited liability company will continue in existence as the resulting entity under the laws of the State of Florida.
- 2. <u>Effective Date of the Conversion</u>.
