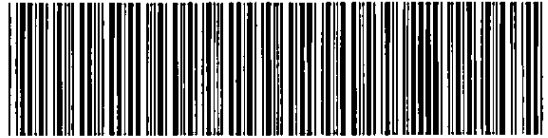

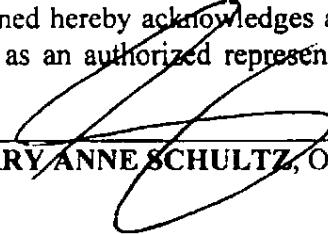
**ARTICLE IX - MANAGEMENT**

**ARTICLE X - AMENDMENT**

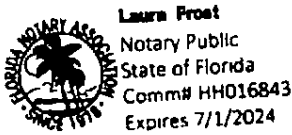
